6. ELIGIBILITY

- 1. Admission in the hostel will be strictly on the basis of merit depending upon the availability of the vacant seats.
- 2. Admission to the College does not imply admission to the Hostel.
- 3. Mere submission of application form does not ensure admission.
- 4. Priority will be given to the students belonging to SC/ST.
- 5. Priority in the admission to the hostel will be given to those students who come from more than 20km. distance from the college.
- 6. Student should fill separate application form for admission to hostel. Candidates can obtain application form from the office of the concerned Hostel (Boys/Girls). The form, completely filled in, along with necessary enclosures, should be deposited with the concerned hostel admission Committee. On the basis of the merit of registered candidates and their fulfilling the required eligibility for admission to hostel a list of eligible candidates will be drawn for counselling. Candidates who will be short listed for Counselling required to appear personally before the hostel admission committee with their Parent (Mother/Father) and local guardian. A final list of selected candidates must deposit the required fee as per instructions and within notified dates.
- 7. Only those students will be considered for admission to the hostel who have deposited their college fees.

8. Hostel students, seeking hostel accommodation will be required to fill new hostel form in every academic session subject to the satisfaction of the warden regarding proper conduct and regular payment of dues of hostel, mess and canteen etc. of previous session.

7. DOCUMENTS REQUIRED

- 1. The candidate should bring attested copies of 10^{th} and 10+2 certificate at the time of admission.
- 2. Two passport size photograph.
- 3. SC/ST certificate from Class I, Magistrate
- 4. Two passport size photographs of parents and one of local guardian and specimen signature who are allowed to see the boarder.

5.Medical fitness certificate is compulsory for the selected candidates at the time of admission to hostel.

6.College admission fee receipt is required at the time of deposition of hostel fee.

10. FACILITIES

The institute has magnificently designed separate hostels for boys & girls each with all modern facilities for boarding & other recreational activities. The hostels have their own mess to provide good & hygienic food to the students.

1. Rooms

Well furnished& specious rooms are there for 105 girls & 90 boys each. There are cubical as well as dormitories for students, each room is equipped with a bed, a study table, study chair and almirah.



2. Mess and Dining Hall facility

It is maintained on co-operative basis so as to provide good & hygienic food. Inmates can enjoy delicious food in the dining hall of the capacity of 24 students.



- 3. Both hostels have common rooms with the facility of LED, indoor games like chess, table tennis etc.
- 4. Bathroom with latest facility and proper maintenance of hygiene.
- 5. Computer room with Wi-Fi and Broad Band facility.
- 6. 24 hours' electricity & water supply is available. Solar and electric water geysers facility is available to enjoy hot water bath in the morning.
- 7. RO+UV water purifier for drinking water and keep student health.
- 8. Well-equipped sick room, guest room and reading room.
- 9. Gym facility for girls and boys.
- 10. Various magazines and newspaper
- 11. CCTV camera facility is also available

11. Rules and Regulations for Residents of Girls/Boys Hostel 11.1 ATTENDANCE AND LEAVE

- 1. Leave for absence from the college shall not automatically entitle a student to leave the hostel without the permission of the Warden. When a student wishes to leave the hostel for one or more days or night, he/she may apply to the warden, in writing and get his/her permission. Leave has to be applied at least 24 hours in advance and boarders can proceed on leave only after ensuring that leave is duly sanctioned by warden.
- 2. A student absenting himself/herself from the hostel without getting his/her leave sanctioned may be subjected to a fine or other disciplinary action.
- 3. A register will be maintained for the purpose by the attendant or security guard in which due entries will be made by Residents.
- 4. No boarders will leave or enter the hostel without making an entry in the departure/arrival register of the hostel.
- 5. All the students are expected to be in the hostel at the time of roll-call which will be taken by the prefect/head boy or girl or attendant on timings fixed by warden and any student absenting himself/herself without the prior permission of the warden will be fined per day.
- 6. All applications for any kind of leave should be written by the boarder student herself and submitted to the Warden giving full address of the place where they intend to go.

- 7. Leave must be got sanctioned before a student avails of it. Boarders, who absent themselves in anticipation of sanction, will ordinarily be considered as absent without leave.
- 8. All applications should bear the name; roll number, class, date and room number.
- 9. The hostel gate will close after regular class time table of the college. After the above mentioned hours late entries will be made in the register maintained for the purpose.
- 10. In case of late entry in the hostels, appropriate disciplinary action will be taken.
- 11. First late registration to the boarders may be allowed with a warning/fine and second instance the student may be expelled.
- 12. Boarder turning from home must report themselves before the roll call time.
- 13. It is mandatory to stay in the hostel during a house exams and university examination. No leave will be sanctioned during this period.

11.2 Guest and visitor

- 1. At the time of admission of their ward, parents/guardians must submit to the warden a list of relatives/ visitors whose names and signs will be approved by the parents who will be allowed to see the student and accompany them. The visitors are expected to sign the visitor's register and state their relation.
- 2. Students are required to meet the visitors in the Visitors Room only.
- 3. Visitors and Boarders both will have to observe visiting hours strictly. The Boarders coming to the hostels will make necessary entry in the register of visitors at the main gate and seek permission from Warden.
- 4. No student shall keep a guest in his/her room except with the permission of the warden.
- 5. Visitors' room at the gate of the Hostel complex will be kept open only during the visiting hours as notified from time to time. It may be opened during non-visiting hours if a relative comes to meet a resident but only on permission from the Warden.
- 6. The Boarders are not permitted to meet visitors inside the hostel premises during college hours. Any student violating this rule will be liable to disciplinary action.
- 7. The visiting hours are from 4.00 pm to 05.30 pm only on *Wednesday* and 2:00 p.m. to 6:00p.m. on *Sunday* in the Visiting Room of the hostel.
- 1. The boys/girls will be allowed to visit local guardians (duly authorized by her parents) only once in a month with the prior permission of warden.
- 2. Day scholar is not permitted to visit or stay in the hostel without the permission of warden.
- 3. Any violation of the above rules will be severally dealt with including expulsion from the hostel.

11.3 FURNITURE AND EQUIPMENT

- 1. The Boarders are expected to arrive a day before the term begins with their own bedding, a lock, a bucket, a mug, curtains for the windows and a CFL bulb.
- 2. Furniture will be issued to the board student against her signature. Before leaving the hostel he/she must obtain a certificate from the warden that the furniture issued has been returned in working condition.
- 3. Students shall keep their rooms neat and tidy and shall be responsible for the furniture issued to them and for the fittings present in their rooms at the time of activity. If a student observes any damages or defect in the furniture issued to him/her or in the permanent fittings in his/her room or finds anything missing at the time he/she occupies the room, it will be his/her duty to bring it in the notice of the hostel office, failing which it will be presumed that everything was in order at the time of hostel admission.

- 4. Furniture shall not be removed from one room to another. The furniture belonging to the common room, dining hall, hostel office or the hostel guest room shall not be taken out or brought into the living rooms. Anybody indulging in this will be liable to disciplinary action.
- 5. When a student vacates his/her room before the summer break or after withdrawal or expulsion, he/she shall return to the hostel office all hostel furniture and other property issued to him/her failing which he/she shall be liable to pay the entire cost of such furniture or other property. Repair charges for any damage to the furniture will have to be paid by the residents. In case of any willful damage to the hostel property including furniture the cost of damage along with penalty will be realized from the defaulters.
- 6. Boarders are not allowed to change their allotted room

11.4 MAINTENANCE OF LAWNS AND CLEANLINESS

- 1. The lawns around the hostels are meant for the benefit of the students and for improving the appearance of the hostels. Students are expected to help and to take interest in their maintenance.
- 2. Spitting, except at places meant for such purposes, is strictly forbidden.
- 3. Walls, furniture and doors etc. shall not be disfigured or damaged with ink, pencil, chalk or knives etc.
- 4. Wash basins shall not be plucked with sand, mud or any other extraneous material. For washing hands only soap should be used.

11.5 WITHDRAWAL/ REMOVAL FROM THE HOSTEL AND VACATION OF HOSTEL ROOM

- 1. 1.A student who desires to withdraw from the hostel shall submit an application on the prescribed form to warden after having cleared all hostel dues.
- 2. Before permitting a student to withdraw from the hostel the warden's office shall ensure that he/she has: a. Cleared all his/her dues to the Hostel.
 - b. Returned, in good condition, all hostel property issued to him/her.
 - c. Cleared all his/her dues, including mess dues and fines, standing against his/her name.
 - d. No student shall be allowed to stay in the Hostel if his/her hostel and mess dues are pending for more than a month.
- 3. No boarder will be allowed to stay in the hostel during winter vacation and summer vacation after the university examinations are over.
- 4. When a student has left the hostel, for whatever reason, without clearing his/her dues to the hostel, the hostel authority may recover outstanding dues from the security deposits. In case the outstanding amount exceeds the amount of deposit, the matter shall be reported by the warden to head of the institution, who shall withhold the result or issue of a provisional certificate, transcript of degree till the balance of the outstanding dues is paid by the student. If such a student has not completed the course the Principal may withhold his/her Character Certificate until he/she gets a clearance chit from the Warden.
- 5. Students will vacate their rooms before the commencement of the Summer Break and hand over to the hostel office the furniture and other property issued to them.
- 6. Student who is knowingly locks up the room when he/she goes home for the vacation, the Warden may take one or more of the actions given below:
 - a. Order that he/she should pay the prescribed Hostel charges, Amalgamated Fund and Electricity Charges for the entire session.
 - b. Break open the lock, checkup hostel furniture issued to him/her and recover from him/her the cost of any loss or damage to hostel property which the warden may notice.
 - c. Remove the belongings of the student, if any left in the room to the hostel store or clock room, the responsibility for the safety of such belongings will rest entirely with the student.

11.6 HOSTEL MESS

- 1. Girls and Boys hostel messes are running on co-operative basis and are supervised by the mess committees. The Convener of the mess committee and its members are nominated from among the students for a fixed period by the Warden and the mess committees should ordinarily be changed after every three months.
- 2. Various varieties of good vegetarian food at reasonable rates are served in the hostel
- 3. All the residents are expected to take their meals in the hostel mess.
- 4. Meals will be served only in the dining hall during the hours notified. However, in case of illness meals can be served in the room, on the recommendation of the Warden of the hostel.
- 5. Boarders will not go into the cooking area.
- 6. Cooking in the rooms is strictly prohibited.
- 7. All the Boarders should come to the hostel mess in proper dress
- 8. Only in special case reduction in the mess charges will be given even if a boarder stays away for long period.

11.7 DEMEANOR AND DISCIPLINE

- 1. Boarders are expected to conduct themselves with dignity and decorum at all times in the hostel.
- 2. They should not disturb other students by making noise.
- 3. Playing of stereo/ two-in -one/ is strictly prohibited. Those who violate the rule will be fined. A frequent violation of this rule may lead to expulsion.
- 4. They should consider college property i.e. building, electrical and sanitary fittings, furniture etc. as their own and not try to damage them in any way. Boarders will have to bear the cost of the repair of the property damaged by them. They are particularly warned not to scribble anything on walls and doors in the hostel.
- 5. Use of abusive language, tearing of page from magazines and newspapers, playing of cards or any other act of breach of hostel discipline will be treated as violation of hostel rules and will invoke suitable punishment.
- 6. As a zero tolerance policy, smoking, consuming liquor & drugs are strictly prohibited. Boarders are not allowed to gamble, consume neither intoxicants nor are they allowed to have possession of them in hostel premises & violation of this rule shall lead to immediate expulsion.
- 7. The residents must not keep iron rod/ weapon/ arms of any kind in the hostel.
- 8. Boarders must not assault any hostel staff. Any complaint of indiscipline or insolence against hostel staff must be reported to the Warden for suitable action.
- 9. Lights should be switched off and taps should be closed when not required. Tea leaves or other rubbish should not be thrown into the sinks, corridors etc.
- 10. Boarders will not tamper with the electrical and sanitary installations. The cost of repairs/ replacement due to any damage done to them will be charged from boarders besides imposition of the fine for violation.
- 11. Boarders are expected to keep their surroundings neat and clean and make proper use of dustbins. Spitting in hostel compounds and corridors is prohibited.
- 12. Boarders should lock their rooms whenever they go out. The responsibility for any loss of goods, money, Jewelry or any other items will be that of the individual.
- 13. Boarders are not allowed to keep the valuables jewelry with them.
- 14. Boarders are required to observe perfect silence in the reading rooms. Games must be played in orderly manner. Nothing should be removed from the reading room, mess, sick room, computer room, guest room or the common room.
- 15. No DVD is permitted in the hostel and no show of pictures or any other visual item is permitted during the day or night. Those who violate the rule will be fined and liable to any other suitable action.
- 16. Warden may recommend expulsion of resident from hostel if he/she is not satisfied with his/her conduct or for violation of the rules.

- 17. No hostler is allowed to maintain/keep/bring motor vehicle (i.e. Cars, Motor Bikes, and Scooter etc.) in the hostel premises.
- 18. In case of non-payment of dues or violation of any hostel rules by a resident, the Warden may get his/her room locked or opened for possession without any liability whatsoever.
- 19. Any student opening a room by breaking the hostel lock or windowpane etc. shall be liable to fine/ expulsion from the hostel.
- 20. It is mandatory for students to maintain minimum required attendance(75%) failing which admission to the hostel in the subsequent semester will be discontinued.
- 21. Any other order, which is notified from time to time, will be binding on Residents.
- 22. Boarders are required to obtain the hostel identity card all the time and produce the same on demand.
- 23. Boarders must look upon the hostel notice board daily for new information and message.
- 24. Failed boarder will not be given admission in the hostel.
- 25. Boarders must be in their rooms from 5:00 p.m. to 9:30a.m. or after college classes. Action will be taken against student found absent from her/his room or moving about during the above mentioned period.
- 26. All rooms including almirahs and belongings of boarder will be opened to inspection for discipline committee, warden, DSW, and principal.
- 27. Cell phones are not allowed in the hostel. The competent authority shall have the power to add to these rules or delete or amend any of the existing rules from time to time. The change shall be binding on the students.

12. BOARDERS PARTICIPATION IN HOSTEL ACTIVITIES

Hostel shall have committees consisting of perfect, Mess representatives, Common Room Secretary, discipline and Cleanliness in charge etc. The committees will be appointed every year by the warden from senior students of good standing to his/her in the administration of hostel. The students shall be involved in the functioning of hostel through various committees constituted by the respective Warden.

13. RAGGING

RAGGING IN ANY FORM IS A HEINOUS CRIME AND PUNISHABLE OFFENCE. IT IS STRICTLY BANNED IN THE COLLEGE. IN CASE OF RAGGING IT IS MANDATORY TO FILE AN FIR.

According to Raghawan committee appointed by Hon'ble Supreme Court, **Ragging** means doing an act which causes or likely to cause an insult or annoyance or fear or apprehension or threat or intimidation or outraging of modesty or injury to a student.

Again ragging means causing, inducing, compelling or forcing a student, whether by way of practical joke or otherwise, to do any act which detracts from human dignity or violates his personality or exposes him to ridicule or to forbear from doing any lawful act by intimidating wrongfully, restraining wrongfully, confining or injuring him of by using criminal force to him or by holding out to him any threat of such intimidation, wrongful restraint, wrongful confinement, injury or use of criminal force.

Ragging is strictly prohibited as per H.P. University ordinance 7.5. if any student individual or group tries to indulge or promote physical or mental torture of newcomer shall be considered guilty of ragging. The H.P. University has framed the rules vide notification No.1-14/HPU/DSW/08-/360 dated 10th July 2008, and as per these rules:

The student found indulging in any act of ragging shall be produced in front of discipline committee and if found guilty, will be punished appropriately which may include:

- i) Expulsion from the college.
- ii) Suspension from the class.
- iii) Fine up to \gtrless 25000/- with public apology.

- iv) Withholding scholarships or other benefits.
- v) Debarring from representation in the events.
- vi) Suspension or expulsion from the hostel or mess.
- vii) Legal proceeding under criminal law shall be initiated

14. PICNIC/ TOUR

A picnic/tour for the boarders of college is organized during the last week of December, so as to provide them an opportunity for exposure & self-learning.
